BOARD NOTES by Chris Stotler, Board Chair

The Board of Directors meeting was held on July 15, 2020 at 1:00 p.m.

Your Board of Directors met via a Zoom teleconference again this month. Mary Corrigan was a special guest who presented information regarding the children's religious education (RE) program.

Mary Corrigan asked the Board for direction about her role in the conduct of youth religious education. The Board complimented her on the youth RE, and particularly on her practice of obtaining input from the youth about their concerns and wishes. We realized that some channels of communication between the RE program and the Congregation require modification because Board Members were unaware of some activities and communications that had been sent in the past several months. To provide a broader source of direction for the RE program, there will be a "stakeholders"

group organized by Rev. CJ and Mary. John Conrad volunteered to be the Board's representative to the stakeholders group that will help develop program support and direction.

The Board evaluated our status in our Plan for Returning to Congregational Life. The Board agreed that we must remain in Phase 1 due to the increasing number of COVID-19 cases and hospitalizations locally. Maybe if the public would wear masks we would be able to move to Phase 2.

Marge DiGalbo reported on her and Bob's review of costs and maintenance issues associated with touchless controls on sinks and toilets. The Board agreed with their conclusion that it should be done when there is a renovation. However, at this time, we will obtain touchless paper towel dispensers and sanitizer dispensers.

The Board discussed additional approaches and programs

that enable more congregants to participate and connect with each other. Some potential programs/activities discussed include holding Odysseys by Zoom; broadcasting live public official interviews on social justice and other topics; starting a "Building Your Own Theology" class; and continuing to encourage joint ventures with other organizations. As we expand our online activities, we must increase the pool of people who can host Zoom meetings. Let us know your interest in these or other potential programs...as well as how you would like to volunteer. In addition, Rev. CJ has been in contact with a person who will recommend improvements in our technology and will assist in developing videos.

Zoom meetings are becoming a routine practice for committees and events. I am glad many of our committees meet by Zoom, but I long for in-person communications. Check

the announcements from Regina about What's Happening at All Faiths, and her emails for Zoom connection information. You can call or email Regina if you missed the e-mail containing Zoom contact information.

Every year there is a review of our financial procedures that is performed by members who are not board members or officers. Ed Kleinow and Ernie Reid agreed to perform this important review; the Board approved them for that role and thank them in advance.

Regarding financial matters, the Finance Committee reports that we are financially healthy compared to other years in both revenue and expenses. Your support during these difficult times is greatly appreciated. We did not anticipate going this long without in-house services, which means there



- Revenue/Income declined significantly in June. This is normal during the summer months when so many "snow birds" are north and church attendance is normally smaller. But the generosity of our congregants is very much appreciated especially during these times of being unable to attend All Faiths in person.
- Expenses have remained lower than budgeted because of the fiscal restraints that the Board approved at earlier Board meetings.
- The Burn-the-Mortgage program continues with donations of \$1,100.00 received in June (\$600.00 in June decreased the Principal; the other \$500.00 will decrease the Principal in July). The outstanding mortgage principal at the end of June was \$109,465.46.
- The Small Business Administration PPP loan was approved on May 1, 2020; and the \$27,300 loan was deposited on May 5. We anticipate that the loan will be forgiven and treated as a grant by the SBA once proper documentation is submitted. Susan Anthony of the Finance Committee is taking the lead on the necessary paperwork to help ensure that the documentation is sufficient and completed on a timely basis.
- In June, \$421 was collected for *The Change* Program, Alliance for the Arts (Racial Justice Team).

MANO A MANO CANCELS TRIP TO BOLIVIA


A Message from Joan Velasquez

The Heart for the Homeless Team continues to Zoom in for our monthly meetings. A couple of new people have joined and contributed to our group, and we invite you to join us for the August 20th meeting. Thanks to Regina we will be ready for you!

We are carrying out our mission through discussion and action on local issues around homelessness, and planning ways All Faiths can learn and support efforts to serve this population.

Thanks to donations from the congregation, we were able to get personal hygiene items to All Souls Episcopal Church for distribution at their weekly meal and homeless ministry.

Additionally, the White Cross Church received a donation of plastic sleeping mats, masks and wipes for their ministry to the homeless. The sleeping mats were made by volunteers from Shell Point and the masks were made by CJ's niece, *Meghan Harvey*. Kudos to them for their generosity.

Team members contacted city council members prior to the July 20 budget meeting, urging them to approve the \$300,000 housing trust fund.

Individual ministries include placing "Green Books" in Little Free Libraries in our community, as well as supporting a "Car Ministry" by handing out socks, water, and other necessities to those who stand at roadway intersection seeking help.

CLARIFICATION ON POLITICAL ACTION FROM THE UUA

Question 1: Can we openly preach, teach, or act about being opposed to war, or supporting the Green New Deal? Have these become partisan issues?

Response: YES YOU CAN. Unless you are persuading people to vote for/against a specific candidate, you are absolutely allowed to take a definitive stance on issues, including issues regarding actions of the current administration. Opposition to war, combating climate change, resisting oppression in all forms—these are foundational UU beliefs. They can and should be at the center of sermons and congregational work.

Question 2: Can we partner with an organization if they are not a 501(c)3?

Response: YES YOU CAN. Congregations can partner with c(4) organizations or unions to carry out charitable, nonpartisan activities consistent with the church's 501(c)3 status and mission. For UU congregations, that includes activities advocating for foundational UU beliefs.

Question 3: Can Individuals from the congregation (espe-

cially the minister) publicly endorse candidates?

Response: YES THEY CAN. So long as the individual is not speaking at an official church function, in an official church publication, or otherwise using the church's assets, and does not claim to speak as a representative of the church, they are free to endorse and speak publicly on behalf of any candidate.

Question 4: Can we ever host partisan activities in the congregation?

Response: YES YOU CAN, as long as the event is consistent with pre-existing space use policies (i.e. - you don't charge for space use and aren't charging the folks holding the partisan event, or you only allow groups invited by a member to use the building). Furthermore, your policies can include a requirement that any group using the space hold similar values to UU principles to avoid having to host groups whose partisan activities are contrary to UU beliefs.
